## Data Protection

We are committed to protecting and respecting your personal information when using our websites and our services and complying with data protection law. This Privacy Policy describes what personal information we may collect from you, why we use your personal information and more generally the practices we maintain and the ways in which we use your personal information.

By providing your personal information to us, you acknowledge that we may use it in the ways set out in this privacy policy. We may provide you with further notices highlighting certain uses we wish to make of your personal information. We may also give you the opportunity to opt-in to selected uses such as marketing when we collect your personal information.

**If you are registering other people for cover under a policy where you are the key contact, and are providing personal information about these individuals, you must ensure that this privacy policy has been drawn to the attention of those individuals and you have their permission to share information with us.**

**Where the individual is under the age of 16 years, you must ensure that you have parental consent to provide personal information relating to the child to us.**

From time to time we may need to make changes to this privacy policy, for example, as the result of government regulation, new technologies, or other changes in data protection laws. You should check any of the above websites periodically to review the most up to date privacy policy.

## Data Controller and Data Processor

International Travel and Healthcare Limited are the data controller and data processor under the Data Protection Act 1998 in relation to the controlling and processing of your personal data in connection with our Travel Insurance Service. We are responsible for complying with data protection laws. ## Who do we collect personal information about?

- Present, past and prospective clients;
- Individuals who enquire about our organisation and its services;
- Individuals that sign up to marketing communications and service updates.

## **When do we collect personal information?**

We may gather, store and use the following kinds of personal data:

- information that you provide to us for the purpose of obtaining a quote, and wish your quote details to be saved, or purchasing a travel insurance policy through us (including your name and address, telephone and email contact details and if you have a medical condition information on your medical history);
- information about your computer and about your visits to and use of this website (including your IP address, geographical location, browser type, referral source, length of visit and number of page views);
- information that you provide to us for the purpose of subscribing to our website services, email notifications and/or newsletters (including your name and address, telephone and email contact details);
- any other information that you choose to send to us.

## **What personal information do we collect?**

- Name;
- Address;
- Phone number;
- Email address;
- Date of birth;
- IP address;
- Password for access to My Account section of the website;
- We may also collect the following sensitive personal information;
- Information about your mental or physical health;
- Children's personal data (if travelling with you and insured under your policy).

## **How do we collect your personal information?**

- By telephone;
- Via call recordings on our voice message service and voice recording service when you call us, or we call you;
- Via our website (including through the use of Cookies – please see section later on Cookies);
- Via registration forms on our website;
- Via emails that you may send us
- From individuals who have registered you for a policy;
- From third parties that you have been introduced to us by.

## **How we will use your personal data?**

Personal data submitted to us will be used for the purposes specified in this privacy policy or in relevant parts of the website.

## **We may use your personal information to:**

- Provide a quote and send you email confirmation or postal documentation of this at your request;
- Issue policies, maintain your policy or send to your renewal terms for your policy via email and if requested via post;
- Send you email notifications which you have specifically requested;
- Deal with enquiries and complaints made by or about you relating to our websites or our services;
- Contact you in relation to a claim;
- Ask you about the service you have received from us in the website that you registered in;
- Analyse customer demographics and to customise and develop the product/services we offer.

Where you submit personal information for publication on our website, we will publish and otherwise use that information in accordance with the license you grant to us.

We will not without your express consent provide your personal information to any third parties for the purpose of direct marketing.

### **Legal grounds under which we process your personal data**

We use your personal information for a number of different purposes.

Under data protection law, for each purpose we must be able to rely on a legal ground to justify why we are using your personal information.

### **Issuing a quote and/or issuing and managing your policy with International Travel and Healthcare Limited**

The processing of your personal and sensitive personal data is necessary for the performance the insurance contract to which you are a party to, or in order to take steps at your request to provide you with a quote prior to entering into an insurance contract.

The legal grounds under which we process your data in these circumstances are to enable us to fulfil the performance of our contract with you, and, for us to comply with legal obligations to which we are subject.

### **Keeping you informed of new services/updates on products/provision of information on a subject you have asked to be kept informed of/specific marketing materials.**

The processing of your personal data and sensitive personal data will only be undertaken upon receiving your explicit legal consent for the specific activity. You will be asked for your consent via our website or over the phone or via email or in writing. We will not send any information to you if you have not explicitly consented to receive this.

You may withdraw your consent at any time by contacting by clicking on the email unsubscribe link or by going to My Account and changing your details in the relevant website or in writing to The Data Protection Officer, International Travel and Healthcare Limited, 15 East Links, Tollgate, Eastleigh, Hampshire, United Kingdom, SO53 3TG. If you do so, you may not be able to receive the benefit of some of our services where in order to provide them, we rely on your explicit consent to process your personal data.

The processing of your personal data for the legitimate interests pursued by us or by a third party, except where such interests are overridden by your interests or fundamental rights and freedoms which require protection of your personal information.

### **How long will we retain your personal information?**

We only keep your personal information for as long as it is reasonably necessary to fulfil the relevant purposes described in this privacy policy or if required by law, we may keep your information for longer.

If you purchase a policy with us we are legally required to retain your personal information for a minimum of seven years. If you consent to your personal information being retained for a quote we will retain your information only for the valid period of that quote which is 30 days.

### **What will we disclose to third parties?**

If you request a quote you consent to us disclosing your personal information to the following parties:

- The insurer of the policy to obtain a premium if your quote requires referral to them. The personal information that will be shared with the insurer at this time will be your name, your contact details and any medical history as declared to us by you.
- If you purchase a product with us we will share your personal information with the insurer of the policy.
- In the event of a claim your personal information will be shared with the Insurer and their appointed claims administration provider and/or emergency assistance company as required. Details of these organisations are stated in the policy terms and conditions.

- Other third parties whose services are included within our products with a view to providing you with a quotation or policy information for their product and/or a service requested by you. When these companies use your data in this way, they will be acting as data controllers of your information and therefore you should view their privacy policies or contact them directly for further information.
- The Financial Conduct Authority and/or other regulatory/governing bodies for the purposes of compliance monitoring;
- Your information may be shared in connection with the sale or potential sale of all or part of our business or the company. You will be sent notice of such an event.
- International Travel and Healthcare Limited reserves the right to disclose personally identifiable information in order to comply with the law, applicable regulations and government requests. We also reserve the right to use such information in order to prevent fraud, protect our operating systems and integrity as well as other users.
- Any third parties employed by us to process your data on our behalf are subject to contractual obligations to protect the security of your data in accordance with the terms of this Privacy Policy.

### **How do we protect your information?**

Once we have received your data we will ensure that it is treated with the utmost respect and in accordance with the Data Protection Act 1998 and any future applicable regulations. Your data will be stored on our secure server within the EU.

We follow strict security procedures in order that the data we collect is stored and disclosed appropriately and securely.

Unfortunately, the transmission of information via the internet is not completely secure.

Although International Travel and Healthcare Limited will do its best to protect your personal data, we cannot guarantee the security of your data transmitted to our site; any transmission is at your own risk.

### **Other Websites**

Please note that clicking on links and advertisements on our websites may result in your transferral to another website, where data privacy practices may vary to that of International Travel and Healthcare Limited. If transferred to another website you should consult their privacy policy as we are not responsible for and have no control over information that is submitted to or collected by these third parties.

### **Keeping your personal data accurate**

# Your Rights

## **The right to access your personal information:**

Subject to any relevant exemptions, you are entitled to see a copy of the personal information we hold about you and to request details of how we use your personal information including any disclosures made. ## COOKIES

### What is a cookie?
